# **Looking Back and Looking Forward**

Looking back on 2005, Local Lodge 1746 had a year that was bitter-sweet. We lost a bargaining unit when **JT Slocomb in** 

Glastonbury, CT closed its doors, due to a lack of orders. The union worked feverishly to help the company stay afloat, but all efforts failed. Approximately 30 members of our Local Lodge lost their jobs due to JT Slocomb closing. We had an arbitration win at UTC Fuel Cells over salary doing bargaining unit work. This was a big win for our members, but we still have an ongoing dispute with the company over this issue, which could bring the parties back before an arbitrator soon.

Pratt & Whitney announced a restructuring plan this fall. Although the company doesn't plan to lay off any members as a result of this, work will be leaving both East Hartford and Middletown. Meet & Confer meetings are in process, as the union argues to keep this work in Connecticut. The first Apprenticeship Class in many years finished up in 2005. This class, which was

negotiated in the 2001 Contract, all graduated into the CANs Module Center. (See article below)

Looking ahead in 2006, we will continue the Meet & Confer process to try and save jobs. Fuel Cells members will elect a Negotiating Committee and negotiate a new Collective Bargaining Agreement to replace the agreement that expires on December 3, 2006. Who knows what else UTC will have in store for us in the coming year. The battles have been many; the support of the membership has been great. With continued solidarity this lodge is poised to take on whatever the company deals us. Remember as we move ahead, the workers at Boeing struck, and held the line on health care takeaways. With SOLIDARITY, we can stop company take-aways, and improve our Contract. Workers at UTC Fuel Cell are the first in the cycle. They need all of our support as they negotiate with the company next year.

Be proud of your union. Be proud of yourselves for making the best jet engines and fuel cells in the world. Have a safe and happy Holiday Season with family & friends.



# Workers' Compensation

From time to time the State of Connecticut Workers' Compensation Commission holds training sessions. Their most recent was held on Thursday, October 27, 2005. Part of the discussion was about "Managed Care Plans" or "Preferred Provider Organizations" (PPOs) under the Workers' Compensation system. Some important points are:

You have a right to see the PPO list if you are injured on the job, however you *must request to see the list.* Plant medical does not have to show it to you if you do not request to see it. Sometimes, even upon request, the injured worker is not shown the PPO list. If this happens, please contact your Business Representative at the Union Hall (568-3000) or District 26 Office (828-0359).

Since the implementation of the PPO in 1993, there are occasionally problems with people who are seen by doctors not on the list; or the medical department attempts to "steer" people to certain doctors that are possibly more sympathetic to the company than to the injured worker. While of concern, these instances are rare. You can ask medical personnel for a recommendation from the PPO list, or contact your IAM Business Representative (phone numbers above).

According to John Mastropietro, the Chairman of the Workers' Compensation Commission, the ability of any company to have a "Managed Care Plan" or PPO list is subject to approval by the Chairman of the Commission. It is a privilege, not a right. If any company does not abide by the guidelines, that privilege can be removed. Without the restrictive PPO list, an injured worker at Pratt & Whitney could choose to be treated with any doctor that is licensed in the State of Connecticut. (UTC Fuel Cells & Hamilton Sundstrand currently do not have a PPO list)

There has also been a misconception about treatment at Plant Medical. Once you have seen some-


see Dr. Ryan (or other medical department doctor) before seeing the treating physician of your choice from the PPO


list. If Dr. Ryan is available when you go to medical, then you should see him. However if he is unavailable, or you can't get an appointment for several days, you have a right to seek treatment from a doctor on the PPO list. You do have to keep the medical department informed of your progress with your treating physician.

You can seek treatment from the medical department, if you choose to. However, if your case is later denied by the insurance carrier and you have to go before the Commissioner, the burden of proof is upon you, as the injured worker. To prove your case, your treating physician must agree in writing that, in their medical opinion, your injury or illness is a direct result of something that happened at your job.

ALWAYS be sure you fill out and submit the CT Workers' Compensation form 30C for any work-related injury or occupational disease.

## **United Way 2005**


