2007 CONTRACT HIGHLIGHTS

It has been a long and arduous task, but through hard work, perseverance, and solidarity IAM members approved a new three year contract. The final tally was 2831 to accept the offer with 326 to reject it.

There are wage increases of 3.5% in each year, a \$3,000 bonus matched at 50% (\$1,500) if it's put into the Savings Plan. The pension multiplier went from \$50 to \$58 per month per year of service. Highlights also include \$2 increases each year to the Savings plan matched at 50% and also increases to the Individual Medical Account (IMA) that are matched at 75% by the Company. In addition, we gained two holidays over the life of the agreement giving us 38 paid holidays. It was the strength on the shop floor that turned the tide and made all of this possible. The Union Negotiating Committee knew the membership on the floor had its back and heard them loud and clear, just as the Company did.

The most important victory of these negotiations is that ALL hourly workers will now be included In Letter 22, Workplace Guarantees and Subcontracting. Letter 20, Indirect Subcontracting and its final sentence, ***"Any decision to subcontract work remains within the sole discretion of the Company"***, will be vanquished once and for all. This means that for ALL workers the Company **will make every reasonable effort to preserve the work presently and normally performed by employees covered by Article 2 of this Agreement who are engaged in production and non-production (indirect) work.** This should dispel the myth that Unions are out for every dollar and can be bought. We stood our ground for our job protection demands on behalf of over 900 of our brothers and sisters and did so with honor. Your support was, and is, greatly appreciated. Thank you and may God bless us ALL.

Thanks goes out to all of the wonderful hourly and salaried employees who contributed to this collection. You have made someone's live better and warmer, due to your generosity.

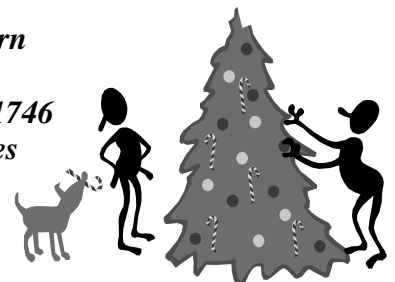
Workers' Aid Collection
