### I.A.M.A.W. LOCAL LODGE 700 ANOUNCMENT

The U.S. Department of Labor will hold an informational meeting at the Courtyard by Marriott in Cromwell on June 19 for people who may have claims for illnesses related to work at CANEL in the late 1950s and early 1960s.

CANEL, the Connecticut Aircraft Nuclear Engine Laboratory, was operated by Atomic Energy Commission (AEC) from 1958-1965. Its original purpose was to develop a nuclear reactor for propelling aircraft. After that program was canceled in 1961, CANEL worked on development of a nuclear reactor for space and other projects involving radioactive materials. CANEL workers may have been exposed to uranium, plutonium, and other radioactive materials. The government sold the facility to United Aircraft in 1965. It is now the site of the Pratt & Whitney Middletown plant.

People who worked at CANEL between 1958 and 1965 may be eligible for benefits under the Energy Employees Occupational Illness Compensation Program Act (EEOICPA). Survivors—including widows and children of CANEL workers—may also be eligible for benefits. This will be explained by the Department of Labor staff on June 19.
