On the good news front, in addition to the recalls that I mentioned in our last insight, a need has been identified for 18 Inspectors, 10 Occ Group 460s in Middletown and 8 176s in TMC. The Company is in the process of offering a choice of those openings to the remaining 460s on the recall list. Of the 2 remaining Occ 464s, one has accepted a job in Middletown and the other should be recalled very shortly. That will clear the recall list for Family 9.

While a couple meetings were cancelled due to scheduling conflicts, we continue to meet with the company over all of the issues relative to Letter 31 of the new agreement. We will have more on the materials issues in our next newsletter.

1. Be an active employee with 12 months seniority
2. Be a Union member in good standing
3. Attend 50% of the Monthly Sunday Membership meetings at the Union hall
4. Submit a nomination slip prior to the election

Why is my injury not being investigated?

Recently an employee asked his Health and Safety rep. to look into why his injury was not being investigated and if the Rep saw the accident report. What the Rep. found out was that there was no ITA (Incident Tracking Analysis) report created by the Co. medical department.

The employee did not clearly state that the injury was work connected. The Medical dept. treated the injury as a personal injury and wrote it in the employee's file but did not submit an ITA report. No ITA report meant there would be no follow up investigation of the injury. The hazard may not then be identified and not corrected.

Make sure Medical knows when you are injured in the work place and that the injury is work connected. Be careful of conversations about activities and hobbies at home. If your supervisor accompanies you to the Medical dept. or clinic, do not allow the supervisor into the examination room. The supervisor is only allowed as far as the waiting room. Protect your rights of privacy when your medical information is involved.

It will be very difficult to file a workers' compensation claim when the Medical Dept. does not identify an injury as work connected.

I hope you will not need this advice. Stay healthy and Stay safe.

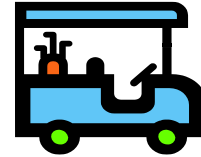

Meeting.

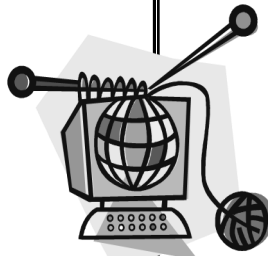
